Social Connections and Financial Incentives: A Quasi Field Experiment in India's Manufacturing Sector

Professor Amrita Dhillon King's College London

(Joint work with Farzana Afridi, Sherry Xin Li and Swati Sharma)

Abstract: Production processes are often organised in teams, yet there is limited evidence on whether and how social connections and financial incentives affect workers' and teams' productivity in tasks that require coordination among co-workers. We conduct a lab-in-the-field experiment in India's manufacturing industry in which workers exert real effort in a minimum-effort coordination game in teams whose members are either socially connected or unconnected, based on their caste, and are paid according to the group output. We find that workers are able to coordinate on higher output levels if they are socially connected with their co-workers. In addition, we find that increasing the power of financial incentives does not reduce the positive effect of social connections- to the contrary, we find that workers respond more to high powered incentives, such as a group based bonus when they work with co-workers with whom they are socially connected, relative to when they are unconnected and as opposed to bonus framed as a loss. Overall, our results underline the importance of social connections with co-workers in determining productivity in the work place.

No country of asylum: 'legitimizing' Lebanon's rejection of the 1951 Refugee Convention

#### About the seminar

How do States 'legitimize' their non-ratification of the 1951 Convention relating to the Status of Refugees and the 1967 Protocol relating to the Status of Refugees? This talk will examine the case of Lebanon, a country frequently hailed by the international community for its generosity towards refugees, and currently hosting the highest number of refugees in the world in proportion to its population size. While Lebanon engaged actively in the establishment of the international refugee regime, it has long insisted that it is not a country of asylum and steadfastly rejects ratification of the major refugee law instruments. Based on field research in Lebanon, the talk will explore four main

arguments as to why Lebanon continues to resist ratification of the 1951 Refugee Convention and its Protocol.

## About the speaker

Maja Janmyr is Professor of International Migration Law at the Faculty of Law, University of Oslo. Her research interests are broadly in the fields of international migration law and socio-legal approaches to international law, with a particular focus on the Middle East. Janmyr holds a PhD in International Law from the University of Bergen in Norway, and is also an affiliated scholar at the American University of Beirut. Janmyr has published widely on a range of refugee law issues, including the book Protecting Civilians in Refugee Camps: Unwilling and Unable States, UNHCR and International Responsibility (Brill, 2014).

# Conference/Call for abstracts/papers

Modern Slavery, Environmental Destruction and Climate Change: A Scoping Workshop

Wednesday, June 6, 2018, 9:30 AM 5:30 PM Room 1-0311 Bedford Square, London, WC1B 3RF (map)

In this <u>exploratory worksho</u>p our aim is to interrogate how environmental change, manifested as climate change, resource depletion or ecological catastrophe, is interlinked with the rise of precarious, informal work across much of the Global South today.

Building on research which documents a longer history of such work in these regions, this workshop aims to address how a newly evolving context of climatic and environmental *vulnerability* is deepening forms of insecurity for labour. It particularly looks to the emergence/ resilience of bonded labour, or other forms of 'modern-day slavery', as a result of this, as well as the role that insecure/precarious labour plays in *perpetuating* global environmental destruction and the climate crisis.

Abstracts are welcome on, but not limited to, the following themes:

- Shifting labour conditions, labour control and labour regimes and environmental change;
- Labour in global production networks and environmental change;
- Labour mobilities driven by environmental change;
- Agrarian/ industrial labour relations as having been shaped/ driven by environmental change;
- Insecurity, vulnerability and risk among labour, shaped by environmental change;
- Labour agency and strategy in the face of environmental change:
- Bonded labour, trafficked labour and other forms of 'modern-day slavery' shaped by environmental change;
- Labour policy/ regulation as a response to environmental concerns.

The workshop will begin to address the evidence gap surrounding this nexus by inviting an inter-disciplinary set of speakers and participants to join us for the day-long workshop. There has also been interest from an academic publisher in turning the workshop into an edited book, and we are also looking into the possibility of putting together a Special Issue from what emerges.

The scoping workshop is organised by the <u>Department of Geography, Royal Holloway University of London</u> in collaboration with the <u>Rights Lab</u> at the University of Nottingham. It builds on cross-institutional interests identified in active projects led by the two universities.

The Department of Geography, Royal Holloway of London is currently undertaking research funded by the <a href="ESRC-DFID Poverty Alleviation programme">ESRC-DFID Poverty Alleviation programme</a> (September 2017-February 2019) entitled 'Blood Bricks: <a href="Examining the Climate Change-Modern Slavery Nexus in the Cambodian Construction Industry">Examining the Climate Change-Modern Slavery Nexus in the Cambodian Construction Industry</a>. The primary objective of this study is to better understand the dynamic interaction between climate change, different axes of structural inequality (e.g. gender, age), and vulnerability to trafficking into modern slavery.

The Rights Lab at the University of Nottingham is home to the world's leading modern slavery experts who are delivering the world's first large-scale research agenda for ending slavery. The Rights Lab's challenge-led approach fuses cutting-edge research with real world application. The Lab is working with governments and NGOs to achieve a Freedom Dividend: the global benefits of ending slavery for economies, rights, health, peace and the environment. It is the latter that underpins the theme of this workshop.

The workshop is supported by the Office of the Independent Anti-Slavery Commissioner (IASC).

Our call for papers seeks cutting-edge research which explores environment-induced modern slavery and/or modern slavery-induced environmental destruction and climate change. We are also cognisant of their 'deadly dance' (Bales, 2016) in ways that transcend this binary distinction. We are delighted that Professor of Contemporary Slavery, <u>Kevin Bales</u> CMG, will present a keynote at the workshop.

The principal goal of this new scheme is to create synergies between the creative arts and academia and promote the College as a centre for artistic research and innovation. The holder of the Fellowship, which is open both to early-career and established candidates, will be expected to undertake a sustained period of intensive work in their field while also participating fully in College life and exploring ways to communicate their work to all members of the College community: fellows, staff, students, and alumni.

The Fellowship can be held for any period between two months and one year, the timescale being determined by the needs of the proposed project.
